04. SPORTS ELIGIBILITY:

The Meritorious Sportspersons will be considered for appointment based on the following criteria:

i) Sportsmen who have represented a State or the Country in the National or International Competition; or Medal winners in Junior National Championships, or Medal winners in Khelo India Youth Games (age category above 18 years), or Khelo India Winter Games; or Khelo India Para Games; or Medal winners in Khelo India University Games; or Medal winners in School Games Federation of India (SGFI) in any of the games/sports mentioned in Para 3.

For Chess: Grand Master (GM) Title, International Master (IM) Title, Chess Olympiad. IM/GM title should be in Open Category like Woman Grandmaster (WGM) etc. While National Open Chess Championship is treated as National Championships, the medal winning performance in National Team Chess Championship will also be considered for recruitment.

- ii) Sportsmen who have represented their University in the Inter-University Tournaments conducted by the Inter-University Sports Boards in any of the sports/ games specified in Para 3, as amended from time to time.
- iii) Sportsmen who have represented the State School Teams in the National Sports/ games for schools conducted by the All India School Games Federation in any of the games/sports mentioned in Para 3.

Note: The order of preference given in Para VI of Consolidated OM No.DOPT-1720781414772 dated 04.03.2024 will be followed in the selection process.

05. EVIDENCE IN SUPPORT OF MERIT IN SPORTS EVENTS/GAMES:

Only certificates awarded by the authorities mentioned hereunder will be taken into account as evidence in support of having participated in competitions in any of the above Sports/Games while considering eligibility of the applicant. A candidate who cannot produce self-attested copies of at least one certificate issued by one of the authorities mentioned below, along with his application, need not apply.

07. The candidate on appointment will **be** liable for posting at any place in Tamilnadu and Puducherry Region.

08. The applicant shall upload attested copies of the following certificates:

- (i) Matriculation/SSC or equivalent certificate for proof of age. (Compulsory)
- (ii) Certificates of Educational qualifications. (As per the requirements of the post)
- (iii) Sports/games certificates as mentioned in Paragraph 5 above
- (iv) SC/ST/OBC community certificate.
- (v) Valid Proof of ID (Aachar Card, Driving License, Passport, PAN Card or Voter ID)
 The candidate must be in possession of the requisite qualification for the concerned post as on the date of his application
- **09.** Candidates who are already employed in Central Government or State Government or PSU should submit the NOC from the present employer which should be uploaded along with the online Application Form.
- 10. The selected candidates will be posted in Tamilnadu and Puducherry region only. The selected candidates will be on probation for 2 years or such period as per the extant instructions of the Government of India. The selected candidate will be required to represent the income Tax Department. His/her participation in the tournament/meets on behalf of the department will also be a deciding factor in his/her probation confirmation.
- 11. Services of the selected candidates as far as participation in sporting activities and leave management etc. shall strictly be subject to fulfilment of the conditions as enumerated in the DOPT's O.M. No. 6/1/85-Estt.
- 12. Application duly filled and completed in all respect, shall be submitted **online on or** before the stipulated date 05.10.2024. The application link in the Department website will be functional till 12:00 Midnight of the stipulated date.
- 13. Application submitted manually and also applications submitted online with soft copies of invalid documents or illegible scanned documents, will be rejected and no correspondence in the matter will be made with the applicant. Shortlisted candidates will be called for Document Verification. The date and venue for Document Verification will be intimated to the shortlisted candidates in due course.
